## BOARD MEETING MINUTES July 12th, 2022

The Moline Township Board: The Moline Township Board meeting was called to order by Supervisor Bonnie Johnson at 4:45pm. The Board met in regular session at the Moline Township Hall,  $620 - 18^{th}$  St, Moline, IL 61265.

Roll Call: Trustees present: Mary Beth Loos, Rand Wilson, Staci Early, Hayleigh Covella and Supervisor Bonnie Johnson.

The Pledge of Allegiance was recited.

Approval of Minutes: After receiving a copy of the June 14th, 2022 Township minutes and having an opportunity to review them, Trustee Covella with a second from Trustee Early moved to approve the June 14th, 2022 minutes. Ayes: Trustees Loos, Wilson, Early, Covella, and Supervisor Johnson.

#### New Business:

Illinois Township Trustee Division Annual Dues - \$30.00 - A motion by Trustee Wilson, with a second from Trustee Covella was made to pay Trustee's dues of \$30.00.

Pay Back 2010 GA Loan to Township: Four-year plan to pay back the Township account for the \$44,000 (2010) loan to GA. First installment of \$14,000 will be paid in July 2022 after Board approval. Remaining installments over next three years of \$10,000 each year until loan is paid in full as advised by the Auditor. A motion by Trustee Covella with a second from Trustee Early was made to approve the pay back Loan to the Township. Ayes: Trustees: Wilson, Early, Covella and Supervisor Johnson. Abstain: Trustee Loos. No Nays. Motion carried.

### Communications – Updates on Township Happenings and MAC Activities:

MAC serves lunch every Wednesday.

Concerts in the Park are underway. Gray Wolf rescheduled to 8/15, due to weather, Crooked Cactus performed on 6/13, and Hotrods performed to a huge crowd on 6/27.
