## BOARD MEETING MINUTES MARCH 10, 2015

**The Moline Township Board:** The Moline Township Board Meeting was called to order by Supervisor Don Johnston at 4:45 pm. The Board met in regular session at the Moline Township Hall, 620 18<sup>th</sup> Street, Moline, IL.

**Roll Call:** Trustees present: Bonnie Johnson, Dan Garza, Mary Beth Loos, Supervisor Don Johnston, Town Clerk J. K. "Jan" Erikson-Vroman and Assessor Dave Hendrickx. Trustee Ethel Perez was absent.

The Pledge of Allegiance was recited.

<u>Approval of Minutes:</u> After receiving a copy of the February, 2015 Township minutes, and having an opportunity to review them. Trustee Johnson, w/a second from Trustee Garza, moved for a motion of approval. Ayes: Trustees: Johnson, Garza, Loos, and Supervisor Johnston. The present Board, by individual roll call, voted unanimously to approve the minutes from the February, 2015 Board Meeting. Motion carried.

<u>Approval of Claims:</u> After reviewing the claims, Trustee Garza, w/a second from Trustee Loos, moved to accept the claims submitted. Ayes: Trustees: Johnson, Garza, Loos and Supervisor Johnston. The present Board, by individual roll call, voted unanimously to approve the claims. Motion carried.

<u>Transfer of Appropriations Ordinance:</u> Trustee Johnson, w/a second from Trustee Loos, moved to approve the Transfer of Appropriations GA Ordinance #2014-4. This is a line item transfer of \$2,000 from GA Emergency Fund to line item GA Utilities Fund. Thus, making the adjusted appropriation for the first line item Eight Thousand Dollars

(\$8,000), and for the second line item Seventeen Thousand Five Hundred Dollars (\$17,500). Ayes: Trustees: Johnson, Garza, Loos and Supervisor Johnston. The present Board, by individual roll call, voted unanimously to approve. Motion carried.

**Payroll Schedule and Payroll Procedures Resolution:** Trustee Garza, w/a second from Trustee Johnson moved for approval of Resolution #2014-2. Ayes: Trustees: Johnson, Garza, Loos and Supervisor Johnston. The present Board, by individual roll call, voted unanimously to approve. Motion carried.

Annual Town Meeting Agenda: Trustee Loos, w/a second from Trustee Garza moved for approval of the Annual Town Meeting Agenda to be held on April 14, 2015 @ 6:01 pm. Ayes: Trustees: Johnson, Garza, Loos and Supervisor Johnston. The present Board, by individual roll call, voted unanimously to approve. Motion carried.
