# BOARD MEETING MINUTES OCTOBER 11TH, 2016

**The Moline Township Board:** The Moline Township Board meeting was called to order by Supervisor Don Johnston at 4:45pm. The Board met in regular session at the Moline Township Hall, 620 - 18th St, Moline, IL 61265.

**Roll Call:** Trustees present: Sam Vasquez, Mary Beth Loos, Rand Wilson, Harry Perez, Supervisor Don Johnston, Assessor David Hendrickx.

The Pledge of Allegiance was recited.

4:48 Township Clerk Bonnie Johnson arrived.

<u>Approval of Minutes:</u> After receiving a copy of the September 2016 Township minutes and having an opportunity to review them Trustee Loos, approved with corrections, and a second from Trustee Perez then motion moved for approval.

Ayes: Trustees: Vasquez, Loos, Wilson, Perez and Supervisor Johnston.

The Board, by individual roll call, voted unanimously to approve the minutes from the September 2016 Board meeting. Motion carried.

<u>Approval of Claims:</u> After reviewing the claims, Trustee Vasquez with a second from Trustee Wilson moved to accept the claims submitted.

**2017 Tax Levy Ordinance:** The Moline Township Tax Levy Ordinance #2016-3 was presented to the Board for the first reading. After their approval there is a 30 day lay over period until the November meeting. After review, Trustee Vasquez, with a second from Trustee Perez moved to accept the Ordinance.

The Board, by individual roll call, voted unanimously to approve the first reading. Motion carried.

Setting Compensation of Moline Township Elected Officials: The Board reviewed Compensation Resolution 2016.2 for the 4 year term beginning May 15th, 2017. Trustee Vasquez with a second from Trustee Perez made a motion to increase salaries for all elected officials at a rate of 2.75% each year for the upcoming term. Ayes: Trustees: Vasquez, Loos, Wilson, Perez and Supervisor Johnston. The Board, by individual roll call, voted unanimously to approve. Motion carried.

<u>3rd Quarter Profit and Loss Statements:</u> The Profit & Loss Statements for Town Fund, GA, the MAC and Assessor was presented to the Board for their review.

The ARC of the Quad Cities: Trustee Vasquez with a second from Trustee Perez moved to pay \$100 to go towards the Building Homes Fund for the ARC of the QC.
